ELIGIBILITY REQUIREMENTS

1. Applicant must be a non-traditional (not directly out of high school) female student.
2. Applicant must plan to attend a Nebraska educational institution.
3. Applicant's course of study must be in an accredited degree/diploma program.
4. Applicant must be in need of financial aid.
5. Applicant is to be a person of good character.

INSTRUCTIONS

1. Application is to be completed by applicant.
2. Please type or print clearly.
3. Attach the following to the completed application:
 - A. A biographical statement, including educational background and goals, financial need and other pertinent information about yourself.
 - B. Three character reference letters. If member of First- Plymouth Church, one letter should come from another church member who is not part of your family.
 - C. Transcript of courses completed (if applicable).
 - D. Completed copy of tax return for current year.

DEADLINES

All application materials must be received by March 31st for consideration. Recipients of the scholarships will be notified on or before May 31. The committee reserves the right to hold personal interviews prior to awarding scholarships.

AWARDING THE SCHOLARSHIPS

The recipients must furnish to the church office confirmation of enrollment in an acceptable Nebraska institution of learning before the scholarship check will be mailed. It will be sent directly to the institution. Acceptable institutions include university, college, community college or trade school. If unsure whether your chosen institution qualifies, please inquire of the Board for Women's Ministries Scholarship Committee. The award must be requested by Nov. 30, 2011.
